# Les Szekely reduces SiteMinder shareholding, plans to retire from Board to support next generation of technology startups

SiteMinder Limited (ASX:SDR) has been informed by Les Szekely (Les), a Non-Executive Director of the SiteMinder Board and the company's first angel investor, of his decision to both reduce his shareholding in SiteMinder from 15.5 million shares to 1.5 million shares, and to retire from his position as a Non-Executive Director by the end of calendar year 2024. This decision was made by Les to allow him to refocus his time and resources towards his passion for technology startup opportunities.

"SiteMinder is at the beginning of an exciting growth journey as it pursues its mission of making sophisticated revenue management accessible to every hotel in the world via its Smart Platform strategy. I am excited for the company's prospects as it progresses its Smart Platform strategy, and I look forward to seeing the material impact it will have on an industry that is seeing a more urgent need for dynamic revenue management than ever before. The potential I see in SiteMinder has never been greater and so, as I have always done, I will remain close to the SiteMinder team and cheer on their success."
