Venue and Voting Information

The Annual General Meeting of the Shareholders to which this Notice of Meeting relates will be held in person at 9.00am AEDT on Wednesday, 28 October 2026 at Grace Hotel Sydney, NSW 2000, Level 1, Pinaroo Rooms 1 and 2 **and** as a virtual meeting.

The Company is pleased to provide shareholders with the opportunity to attend and participate in a virtual Meeting through an online meeting platform powered by Automic.

Shareholders that have an existing account with Automic will be able to watch, listen and vote online.

Shareholders who do not have an account with Automic are strongly encouraged to register for an account **as soon as possible and well in advance of the Meeting** to avoid any delays on the day of the Meeting.

Your Proxy instruction must be received no later than 48 hours before the commencement of the Meeting. **Proxy Forms received later than this time will be invalid.**

Power of Attorney

If the proxy form is signed under a power of attorney on behalf of a shareholder, then the attorney must make sure that either the original power of attorney or a certified copy is sent with the proxy form, unless the power of attorney has already provided it to the Share Registry.

Corporate Representatives

If a representative of a corporate shareholder or a corporate proxy will be attending the Meeting, the representative should bring to the Meeting adequate evidence of their appointment, unless this has previously been provided to the Share Registry.

Technical difficulties

Technical difficulties may arise during the course of the Annual General Meeting. The Chair has discretion as to whether and how the Meeting should proceed in the event that a technical difficulty arises. In exercising his discretion, the Chair will have regard to the number of Shareholders impacted and the extent to which participation in the business of the Meeting is affected. Where he considers it appropriate, the Chair may continue to hold the Meeting and transact business, including conducting a poll and voting in accordance with valid proxy instructions. Resolutions

Remuneration Report

1. Resolution 1 – Adoption of Remuneration Report

To consider and, if thought fit, to pass the following resolution as an **Ordinary Resolution**:

“That, for the purpose of Section 250R(2) of the Corporations Act and for all other purposes, approval is given for the adoption of the Remuneration Report as contained in the Company’s Annual Financial Report for the financial year ended 30 June 2026.”

Note: The vote on this Resolution is advisory only and does not bind the Directors or the Company. Shareholders are encouraged to read the Explanatory Statement for further details on the consequences of voting on this Resolution.

Voting Exclusion Statement: In accordance with the Corporations Act, the Company will disregard any votes cast on Resolution 1 by or on behalf of a member of the Company’s key management personnel (including the Directors), whose remuneration details are included in the Remuneration Report (**KMP**), or any of that person’s Closely Related Parties (such as close family members and any controlled companies of those persons) (collectively referred to as **Restricted Voter**). However, the Company need not disregard a vote if:

- (a) it is cast by a person as a proxy appointed in writing that specifies how the proxy is to vote on Resolution 1; and
- (b) it is not cast on behalf of a Restricted Voter.

If you appoint the person chairing the Meeting (**Chair**) as your proxy and you are not a Restricted Voter, by submitting the Proxy Form you authorise the Chair to exercise the proxy even though Resolution 1 is connected directly or indirectly with the remuneration of a KMP, and you will be taken to have directed the Chair to vote in accordance with his or her stated intention to vote in favour of Resolution 1. If you do not want your vote exercised in favour of Resolution 1, you should direct the Chair to vote “against”, or to abstain from voting on, this Resolution.

Undirected proxy

The Chair of the meeting is deemed appointed where a completed proxy form is submitted which does not contain the name of the proxy or where the person appointed on the form is absent from the meeting or does not vote in accordance with your directions. If you direct the Chair how to vote on a Resolution, the Chair must vote in accordance with your direction.

If you appoint the Chair of the meeting as your proxy or the Chair of the meeting is appointed as your proxy by default, and you do not mark a voting instructions box for Resolution 1, then by completing and submitting the proxy form, you will be expressly authorising the Chair of the meeting to exercise the proxy as the Chair sees fit in respect of Resolution 1 even though Resolution 1 is connected directly or indirectly with the remuneration of the Company’s KMP. The Chair intends to vote in favour of Resolution 1.

Re-election of Directors

2. Resolution 2 – Re-election of Jenny Macdonald as Director

To consider and, if thought fit, to pass the following resolution as an **Ordinary Resolution**:

"That for the purposes of the Company's Constitution and all other purposes, Jenny Macdonald, a Director who retires by rotation in accordance with the Company's Constitution and ASX Listing Rule 14.5, and being eligible offers herself for re-election, is re-elected as a Director of the Company, in accordance with the Company's Constitution effective immediately."

3. Resolution 3 – Re-election of Paul Wilson as Director

To consider and, if thought fit, to pass the following resolution as an **Ordinary Resolution**:

"That for the purposes of the Company's Constitution and all other purposes, Paul Wilson, a Director who retires by rotation in accordance with the Company's Constitution and ASX Listing Rule 14.5, and being eligible offers himself for re-election, is re-elected as a Director of the Company, in accordance with the Company's Constitution effective immediately."

Grant of Performance Rights to the Managing Director and Chief Executive Officer

4. Resolution 4 – Grant of Performance Rights to the Managing Director and Chief Executive Officer (Managing Director and CEO)

To consider and, if thought fit, to pass the following resolution as an **Ordinary Resolution**:

"That, for the purpose of ASX Listing Rule 10.14 and for all other purposes, approval be given, for the grant of 361,889 Performance Rights over Shares in the Company to the Managing Director and CEO, Sankar Narayan, in respect of his FY2027 LTI award, in accordance with the terms of the EEIP and as set out in the Explanatory Statement below."

Voting Exclusion Statement: The Company will disregard any votes cast in favour of Resolution 4 by or on behalf of:

- (a) a person referred to in Listing Rule 10.14.1, 10.14.2 or 10.14.3 who is eligible to participate in the EEIP; and
- (b) an associate of that person or those persons,

as well as any votes cast by members of the KMP and their Closely Related Parties as proxies.

However, this does not apply to a vote cast in favour of Resolution 4, which is cast:

- (a) by a person as proxy or attorney for a person who is entitled to vote on Resolution 4, in accordance with directions given to the proxy or attorney to vote on Resolution 4 in that way; or
- (b) by the Chair of the Annual General Meeting acting as a proxy or attorney for a person who is entitled to vote on Resolution 4 and the appointment expressly authorises the Chair to exercise the proxy as the Chair decides; or
- (c) by a holder acting solely as a nominee, trustee, custodial or other fiduciary capacity on behalf of a beneficiary, provided:
 - written communication is provided by the beneficiary that the beneficiary is not excluded from voting and is not an associate of a person excluded from voting; and
 - the vote is cast in accordance with the directions of the beneficiary to the holder.

If you appoint the Chair as your proxy and you are not a Restricted Voter, by submitting the Proxy Form you authorise the Chair to exercise the proxy even though Resolution 4 is connected directly or indirectly with the remuneration of a KMP, and you will be taken to have directed the Chair to vote in accordance with his or her stated intention to vote in favour of Resolution 4. If you do not want your vote exercised in favour of Resolution 4, you should direct the Chair to vote "against", or to abstain from voting on, these Resolutions.

Undirected proxy

The Chair of the meeting is deemed appointed where a completed Proxy Form is submitted which does not contain the name of the proxy or where the person appointed on the form is absent from the meeting or does not vote in accordance with your directions. If you direct the Chair how to vote on a Resolution, the Chair must vote in accordance with your direction.

The purpose of this Explanatory Statement is to provide information which the Directors believe to be material to Shareholders in deciding whether or not to pass the Resolutions in the Notice of Meeting.

If you are in any doubt about what to do in relation to the Resolutions contemplated in the Notice of Meeting and this Explanatory Statement, it is recommended that you seek advice from an accountant, solicitor or other professional advisor.

Full details of the business to be considered at the Annual General Meeting are set out below.

Financial statements and reports

In accordance with the Constitution and the Corporations Act, the business of the Annual General Meeting will include receipt and consideration of the Annual Financial Report of the Company for the financial year ended 30 June 2026 together with the declaration of the Directors, the Director's Report and the Auditor's Report.

In accordance with the amendments to the Corporations Act, the Company is no longer required to provide a hard copy of the Company's Annual Financial Report to Shareholders unless a Shareholder has specifically elected to receive a printed copy.

Whilst the Company will not provide a hard copy of the Company's Annual Financial Report unless specifically requested to do so, Shareholders may view the Company's Annual Financial Report on its website at <https://www.siteminder.com/>.

No resolution is required for this item, but Shareholders will be given the reasonable opportunity to ask questions and to make comments on the management and performance of the Company.

The Company's auditor will be present at the Meeting. During the discussion of this item, the auditor will be available to answer questions on the:

- Conduct of the audit;
- Preparation and content of the Auditor's Report;
- Accounting policies adopted by the Company in relation to the preparation of the financial statements; and
- Independence of the auditor in relation to the conduct of the audit.

If you would like to submit a written question about the content of the Auditor's Report or the conduct of the audit of the Annual Financial Report by the Company's auditor, please send your question to the Company Secretary. A list of qualifying questions will be made available at the Meeting.

Resolutions

Remuneration Report

Resolution 1 – Adoption of Remuneration Report

In accordance with section 250R(2) of the Corporations Act, the Company is required to present to its Shareholders the Remuneration Report as disclosed in the Company's Annual Financial Report.

The vote on the Resolution is advisory only and does not bind the Directors or the Company. The Remuneration Report is set out in the Company's Annual Financial Report and is also available on the Company's website at <https://www.siteminder.com/>.

However, if at least 25% of the votes cast are against the adoption of the Remuneration Report at the 2026 Annual General Meeting, and again at the 2027 Annual General Meeting (**2027 AGM**), the Company will be required to put a **Spill Resolution** to the shareholders. The Spill Resolution would call a Spill Meeting where affected directors must stand for re-election. If more than 50% of Shareholders vote in favour of the Spill Resolution, the Company must convene the Spill Meeting within 90 days of the 2027 AGM. All of the Directors who were in office when the 2027 Directors' Report was approved, other than the Managing Director, will (if desired) need to stand for re-election at the Spill Meeting.

The Remuneration Report explains the Board's policies in relation to the nature and level of remuneration paid to KMPs (including Directors) and sets out remuneration details, service agreements and the details of any share-based compensation.

Voting

Note that a voting exclusion applies to Resolution 1 in the terms set out in the Notice of Meeting. In particular, the Directors and other Restricted Voters must not vote on this Resolution and must not cast a vote as proxy, unless the appointment gives a direction on how to vote, or the proxy is given to the Chair and you submit the Proxy Form, authorising the Chair to exercise the proxy even though Resolution 1 is connected directly or indirectly with the remuneration of a KMP and that in doing so you will be taken to have directed the Chair to vote in accordance with the Chair's stated intention to vote in favour of Resolution 1.

Shareholders are urged to read carefully the Proxy Form and to provide a direction to the proxy on how to vote on this Resolution.

Election of Directors

Resolution 2 – Re-election of Jenny Macdonald as Director

Rule 6.1 of the Company's Constitution requires that at each Annual General Meeting one-third of the Directors, rounded down, if necessary, to the nearest whole number, must retire from office. The retiring Directors must not be a Chief Executive or Managing Director. The Directors to retire at the Annual General Meeting are those who have been in office the longest since their last election.

ASX Listing Rule 14.5 also provides that an entity which has Directors must hold an election of Directors at each Annual General Meeting.

Jenny Macdonald was appointed a Director of the Company on 15 October 2021 and is Chair of the Audit and Risk Committee. She was re-elected at the SiteMinder AGM on 28 October 2024. The Board considers Jenny Macdonald to be an Independent Director.

Under this Resolution, Jenny Macdonald has elected to retire by rotation, and being eligible, seeks re-election as a Director of the Company at this AGM.

Experience and Expertise

Jenny Macdonald has a background in financial and general management roles across a range of industry sectors including fast moving consumer goods, resources, travel and digital media. She has a proven track record of developing and implementing strategy with a focus on risk management, growth and value creation. Jenny was previously Chief Financial Officer and Interim Chief Executive Officer at Helloworld Travel and Chief Financial Officer and General Manager International at REA Group.

Jenny has held previous directorships at Healius Limited (ASX:HLS), Redbubble (ASX:RBL) and Bapcor Limited (ASX: BAP).

Jenny is currently the Chair of SiteMinder's Audit and Risk Committee and a member of the People and Culture Committee. She is also a Non-Executive Director of the Koala Company Limited (ASX:KOA), Chair of its Audit and Risk Committee and a member of its Remuneration and Nominations Committee.

Qualifications

Jenny is a member of the Chartered Accountants of Australia and New Zealand, has a Masters of Entrepreneurship and Innovation from Swinburne University and is a Graduate member of the Australian Institute of Company Directors.

Directors' recommendation

The Directors (excluding Jenny Macdonald) recommend that Shareholders vote in favour of this Resolution.

Resolution 3 – Re-election of Paul Wilson as Director

Rule 6.1 of the Company's Constitution requires that at each Annual General Meeting one-third of the Directors, rounded down, if necessary, to the nearest whole number, must retire from office. The retiring Directors must not be a Chief Executive or Managing Director. The Directors to retire at the Annual General Meeting are those who have been in office the longest since their last election.

ASX Listing Rule 14.5 also provides that an entity which has Directors must hold an election of Directors at each Annual General Meeting.

Paul Wilson was appointed a Director and Non-Executive Director of the Company on 7 May 2012 and sought re-election at the AGM on 30 October 2023. The Board does not consider Paul Wilson to be an Independent Director.

Under this Resolution, Paul Wilson has elected to retire by rotation, and being eligible, seeks re-election as a Director of the Company at this AGM.

Experience and Expertise

Paul Wilson is co-founder and Managing Partner of ASX-listed technology focused expansion capital fund Bailador Technology Investments (ASX:BTI), a long-time shareholder of SiteMinder. Paul has previously served as a director of a number of global technology businesses and ASX

listed companies. Paul has extensive private equity investment experience as a director of CHAMP Private Equity in Sydney and New York, with MetLife in London and as Executive Director at media focused investment group Ilyria Pty Ltd. Paul is a member of SiteMinder's Audit and Risk Committee and a member of the Company's People and Culture Committee.

Qualifications

Paul has a Bachelor of Business from Queensland University of Technology, is a Fellow of the Financial Services Institute of Australia, a member of the Institute of Chartered Accountants of Australia and a member of the Australian Institute of Company Directors.

Directors' recommendation

The Directors (excluding Paul Wilson) recommend that Shareholders vote in favour of this Resolution.

Resolution 4 – Grant of Performance Rights to the Managing Director and CEO, Mr Sankar Narayan

Background

The Board is proposing to grant the Managing Director and CEO 361,889 Performance Rights in respect of his FY2027 LTI.

Each Performance Right is a right to receive one Share, subject to the satisfaction of the performance and service-related conditions over the performance period. The terms of the Performance Rights are summarised below.

The Managing Director and CEO's FY2027 LTI award is being granted in the form of Performance Rights as the Company issues performance-based LTI awards to align the interests of management with those of Shareholders. Vesting will be contingent upon meeting two performance measures and fulfilling an ongoing service condition. Twenty-five percent (25%) of the Performance Rights will be subject to a relative TSR performance measure, and 75% of the Performance Rights will be subject to a "Rule of 40" performance measure, together with positive Adjusted Free Cash Flow (FCF).

Further details on the performance measures are set out in the table entitled "Key terms of the Performance Rights" below.

Approvals sought

ASX Listing Rule 10.14 requires the Company to obtain Shareholder approval for the issue of securities to a Director under an employee incentive scheme. Approval is being sought pursuant to ASX Listing Rule 10.14.1, as the Managing Director and CEO is a director of the Company.

The Company wishes to have flexibility to satisfy Performance Rights by way of issuing new Shares or acquiring Shares on-market. Accordingly, Shareholders are asked to approve the grant of 361,889 Performance Rights to the Managing Director and CEO under the EEIP, on the terms and conditions set out below. Approval of this Resolution will also result in the Performance Rights granted to the Managing Director and CEO being included as an exception to the approval requirements of ASX Listing Rule 7.1. This means the Performance Rights granted to the Managing Director and CEO, and any other Shares issued pursuant to this approval, will not use up part of the 15% limit available under ASX Listing Rule 7.1. Subject to Shareholder approval being obtained, the Performance Rights will be issued to Mr Sankar Narayan within 12 months of the date of the Meeting (or such later date as permitted by any ASX waiver or modification of the ASX Listing Rules). It is anticipated that the Performance Rights will be issued on one date.

If approval is not obtained from Shareholders, then the Board will consider whether to proceed with the grant by acquiring Shares on-market, or making a cash equivalent payment, to satisfy vested Performance Rights or making the grant on different terms.

Key terms of the Performance Rights

Term

Details

Performance Right measures and weightings -75% Rule of 40

Seventy-five percent (75%) of the Performance Rights will be subject to (a) a Rule of 40 performance measure, and (b) aggregate Adjusted Free Cash Flow being positive, with no annual testing, and both (a) and (b) will be measured over 3 years. The LTI is constructed to incentivise sustained performance over the performance period. Vesting will occur on a straight-line basis between threshold and maximum, with 100% vesting at a Rule of 40 outcome of 40 and up to 150% vesting for outperformance above 40. Vesting is conditional on achieving positive aggregated Adjusted Free Cash Flow over the performance period.

Rule of 40 is calculated as the sum of (i) Revenue CAGR and (ii) Adjusted Cash EBITDA margin, each measured over the performance period. The Board considers Rule of 40 to be aligned with the Company's strategic objectives and long-term value creation, while providing flexibility to adjust the balance between growth and profitability depending on market conditions and strategic priorities.

Revenue CAGR is calculated on a constant currency and organic basis, which removes the impact of foreign exchange rate movements, acquisitions, divestments, and items that are non-recurring or non-operational in nature. Adjusted Cash EBITDA margin is calculated as the aggregate Adjusted Cash EBITDA divided by aggregate revenue. Adjusted Cash EBITDA is calculated by taking Adjusted EBITDA, subtracting capitalised employee costs related to product development, and adding back share-based payment expenses. Aggregate Adjusted Free Cash Flow is calculated as the sum of aggregate adjusted operating cash flow and aggregate adjusted investing cash flow over the three-year performance period. The financial metrics used to calculate Adjusted Free Cash Flow exclude inorganic and non-operational items, including but not limited to restructuring costs, and acquisition and disposal activity. The measure requires cumulative Adjusted Free Cash Flow over the performance period to be positive.

SiteMinder has changed the profitability component of its Rule of 40 measure from Adjusted Free Cash Flow margin to Adjusted Cash EBITDA margin to better align with measures commonly used by investors and to reduce the impact of working capital movements. This is particularly relevant as products such as the Smart Distribution Program, Dynamic Revenue Plus and Demand Plus continue to scale. These products are billed in arrears, meaning revenue is recognised ahead of cash collection, which can temporarily reduce free cash flow despite delivering positive operational performance and increasing long-term shareholder value creation.

Accordingly, the change is intended to ensure management's LTI outcomes are more closely aligned with underlying business performance. The targets remain appropriately challenging under this new measure. SiteMinder's Rule of 40 performance in FY26 was 25.9% under the previous Adjusted Free Cash Flow methodology and remains broadly comparable at 25.2% under the new Adjusted Cash EBITDA methodology.

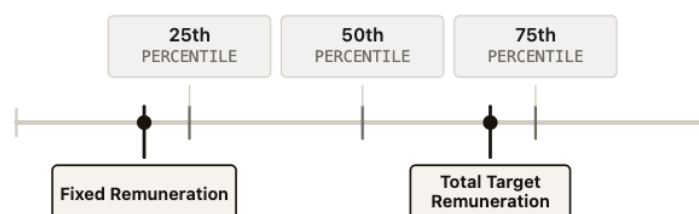

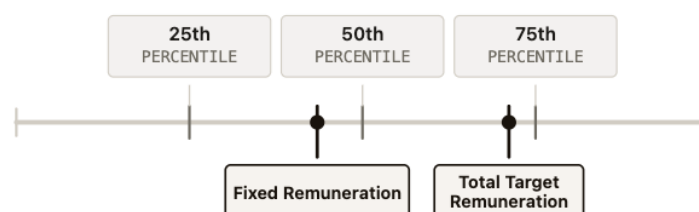
This rebalancing continues in FY27, with an increase to fixed remuneration, bringing the Managing Director and CEO's fixed remuneration closer to market median, partially offset by a reduction in variable remuneration. The overall impact is an 8.1% increase in Total Target Remuneration.
